Sub: Manipal University, Manipal - Renewal of recognition of MD(Pathology) qualification for 06 seats and DCP qualification for 12 seats in respect of students being trained at Kasturba Medical College, Mangalore.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Council Assessor's Report (27.04.2016 for Degree and 30.04.2016 for Diploma) on the physical and other teaching facilities available at Kasturba Medical College, Mangalore for Renewal of recognition of MD(Pathology) qualification for 06 seats and DCP qualification for 12 seats under Manipal University, Manipal and the Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

“The Postgraduate Medical Education Committee considered the Council Assessor's Report (27.04.2016 for Degree and 30.04.2016 for Diploma) and decided to recommend to the Central Govt. that the recognition of MD (Pathology) qualification for 12 seats granted by Manipal University, Manipal in respect of students being trained at Kasturba Medical College, Mangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

However, maximum permissible seats as per available faculty 16 and the college is admitting 18 students. In future the college will admit 6 degree and 10 diploma students which is commensurate with available clinical material.”
